

Privacy Policy

This Privacy Policy outlines how Technicz ("we," "our," or "us") collects, uses, and protects the information you provide when you visit our website and subscribe to our email marketing services. We are committed to ensuring the privacy and security of your personal data in compliance with the General Data Protection Regulation (GDPR).

DATA CONTROLLER

Technicz, with its registered office at Oudeweg 74, 3950 Bocholt, Belgium, is the data controller and responsible for ensuring compliance with the applicable data protection laws regarding the processing of personal data collected through this website.

LEGAL BASIS FOR PROCESSING

We process your personal data based on your explicit consent, in accordance with Article 6(1)(a) of the GDPR. You may withdraw this consent at any time (see below under "Your Rights").

CONSENT

When you provide us with personal information to complete a transaction, verify your credit card, place an order, arrange for a delivery or return a purchase, we understand this as your consent to collect and use your information for that specific purpose only.

If we request your personal information for a secondary reason, such as marketing, we will either ask you directly for your explicit consent or provide an opportunity to opt out.

INFORMATION WE COLLECT

- **Name** (optional): Your first and last name
- **Email address**: To send newsletters, updates, and promotional materials

HOW WE USE YOUR INFORMATION

We use your personal data to:

- Send you newsletters, updates, and promotional materials about our products and services
- Improve our website, services, and marketing based on user preferences and behavior

DATA RETENTION

We retain your personal data only for as long as necessary to fulfill the purposes described above, or as required by applicable laws.

DATA SECURITY

We implement appropriate technical and organizational measures to safeguard your data against unauthorized access, disclosure, alteration, or destruction

DATA SHARING AND THIRD PARTIES

We do not sell, rent, or trade your personal data. Your information may be shared with trusted service providers (data processors) who help us operate our website and deliver services, under strict confidentiality and only under our instructions. All such parties are bound by GDPR-compliant agreements.

YOUR RIGHTS
